In this society, everyone will be more or less affected by external favors, power and interests. If everyone finds a reason for their violations that they consider to be "reasonable", then the rules will not be able to play their due role, especially in under the conditions of a major epidemic, weak consciousness of rules or even no consciousness of rules at all, and behaviors that ignore laws and regulations will cause rules to become invalid. Only when rules are supreme can rules be followed. Only when college students are in awe of the rules can they respect the rules. Under the normalization of the prevention and control of the "COVID-19", college students, whether on campus or off campus, whether in daily study or life, should establish the concept of putting rules first. Only in this way can they gradually establish a consciousness of rules. This sense of awe and respect for the rules requires college students to come from the heart in their daily study and life under this specific condition. 2.2 Rule discovery consciousness

Rule discovery consciousness not only requires college students to know the existence of this rule, but more importantly, it requires college students to learn and master the specific connotation of the rule based on the discovery of the rule, and to have a certain cognitive understanding of the rule, so as to identify with the rule to be fully prepared.

2.3 Rule identification consciousness

The core issue of the rule identification is the value identification of the rules. The college students' rule identification consciousness mainly refers to the college students' value identification consciousness of the rules. The academic community believes that "value identity refers to the process of value subjects constantly changing their own value structure to conform to social value norms, and it

Undergraduates' identification with rules is a kind of ideological value identification based on the individual's discovery and experience of the content and form of the rules through their own subjective rethinking. 2.4 Rule compliance consciousness

Reporting your personal information and other behaviors that seriously violate the school's epidemic prevention and control work system and relevant regulations are a great misunderstanding of "freedom." The consciousness of compliance with the rules of college students can help college students restrain their incorrect so-called "freedom", which has the effect of restraining individual violations. Under the conditions of the epidemic, the formation of the awareness of rule compliance requires the group of college students to reconfirm the rationality of the rules on the basis of cognition of the rules, and deepen the recognition of the rules. Regardless of the rules, they need to be obeyed in order to realize their original value. Only when the college students have the consciousness of observing the rules can they sincerely practice the observance of the rules in their own behavior.

3. Characteristics of college students' consciousness of rules under the epidemic

3.1 Have a high level of consciousness and recognition of the rules

Most college students at this stage were born between 1997 and 2003. They are usually referred to as "post-95s" and "post-00s." Undergraduates at this age have a strong self-awareness, pay more attention to themselves, independent thinking, strong curiosity, and strong ability to accept new things. After receiving the ideological and moral education in elementary and middle school systems, their physical and mental development tends to mature, their understanding of life purpose and meaning in life gradually deepens, their attitudes toward life gradually become clear, their personalities tend to be stereotyped, and their outlook on life, ethics and values gradually becoming mature and stable, therefore, they have their own unique insights into the concept of "rules".

College students' cognition and identification of rules include the cognition and identification of laws and regulations, and the cognition and identification of civic ethics. Laws and regulations have a strong and explicit effect on letting college students clarify what can be done, what can't be done, what actions are legal, and what actions are illegal in the form of legal provisions. Therefore, laws and regulations have the highest effect among all kinds of rules, and they are also the first to follow the rules of college students under epidemic conditions. The vast majority of college students have basic awareness of laws and regulations, and their recognition of laws and regulations is the first in terms of rule identification. 3.2 Strong willpower to follow the rules

The physical and mental development of college students at this stage tends to mature, and they have their own judgments, opinions, beliefs and actions for various formal and informal rules of external information dissemination, and they will not be easily affected by other external factors and others. In the face of clear-text rules that need to be followed, most college students have firm beliefs and tenacious perseverance. They can distinguish priorities, eliminate all kinds of temptations, face them bravely, overcome difficulties, and complete tasks from the beginning to the end. Most college students have good self-control ability, can consciously abide by laws and regulations, school rules and disciplines, strive to restrain their inner impulses and unreasonable requirements, adjust and control their own bad emotions, and ensure their adaptability to various rules. Because the life experience, knowledge level, and psychological development of individual college students are not exactly the same, and the willpower level of college students is not exactly the same, but the vast majority of college students have the willpower to consciously abide by the rules, and can stick to their own interests in the face of interests the bottom line is to resolutely not violate laws and regulations or violate discipline. The strong sense of social responsibility displayed by college students under the epidemic conditions is a manifestation of their will to abide by the rules. Many colleges and universities have become part of volunteers for epidemic prevention and control. In this process, they have been tempered and tempered, fully demonstrating their understanding and recognition of the various rules under the conditions of the new crown pneumonia epidemic, and their ability to abide by the rules of strong willpower.
