2.3 The criminal suspect has a solid social status and network of relationships

Some criminal suspects have a relatively stable social status, have strong confidence in the relationship network they have established over the years, and firmly believe that they can "move up the case" by using money and other means, so they have a strong sense of forgiveness.

2.4 Pretending to be a crime

Due to the rapid and detailed reporting of criminal cases by public media such as the Internet and newspapers, as well as the emergence of a large number of film and television dramas involving crime and criminal investigation, the anti-surveillance knowledge that criminals can master has also become more and more abundant. For example, some criminals will carefully disguise their faces, figures, fingerprints, footprints, etc., in an attempt to hide their identity.

2.5 Evidence of Breaking Crime

Some criminals have certain criminal experience or judicial knowledge, and have a clearer understanding of the importance of criminal evidence in the determination of crimes. They know that cases without important evidence such as stolen money, stolen goods, and murder weapons cannot be transferred to the procuratorate for prosecution At the stage, the confession of the criminal suspect alone is not enough to finalize the case, so these criminals will destroy the relevant criminal evidence after the execution of the criminal act, creating opportunities for themselves to escape the trial of the law.

They establish offensive and defensive alliances in advance, agree on countermeasures after arrest, and try to cover up criminal acts in an attempt to fool through the border.

2.7 Determining that investigators did not have evidence of their crimes

Some investigators with inexperience in handling cases may expose the fact that they do not have enough criminal evidence in the process of interrogating criminal suspects, and some criminals will make the criminal evidence useless by finding suitable reasons. If after multiple interrogations are conducted on the criminal suspect, the interrogator still only talks about legal policies, and generally asks the criminal suspect to take the initiative to explain the facts of the crime, but does not produce favorable evidence, and even the issues raised do not involve criminal acts. Victims or witnesses who fear retaliation or receive money from criminals may refuse to provide cases. Evidence. Similar situations have repeatedly appeared in case investigations, which has brought a strong sense of forgiveness to criminal suspects' escape from legal sanctions.

2.9 Cases where the confession is decisive

Criminals in cases of rape, bribery, poisoning and homicide often have strong forgiveness. Suspects in rape, especially those who have known the victim in the first place, tend to The rape is tricked into adultery, so the forgiveness is more serious. The criminal process of bribery and bribery is one-on-one, as long as both the bribe and the bribe refuse to plead guilty, or the briber still refuses to plead guilty if the bribe confesses, The end result of sci-fi is likely to be left behind due to lack of sufficient evidence. Similar situations exist in cases of poisoning and homicide.

2.10 I think I can no longer avoid legal liability but insist on refusing to plead guilty

Some criminals are very aware of the seriousness of their crimes, but they cannot psychologically bear the legal consequences of this, so they try to avoid legal sanctions through "no confession".

3.3 Dismantling the suspect's offensive and defensive alliance from the inside

If interrogators lack responsibility, interrogation skills and interrogation strategies, they are likely to encourage criminal suspects to create fluke mind, which will finally put interrogators in a bad position.

In recent years, due to the low professional skill level, weak legal awareness and low psychological quality of some investigators, they are investigated and affixed legal liability from time to time since criminal suspects have been extorted confession. Hence, interrogators must perfect their knowledge structures through constant learning firstly. They should arm themselves by learning culture, theories and social knowledge, hitting criminals psychologically through their professional knowledge of politics, laws and interrogation. Moreover, they should practice themselves positively to improve their professional skill level.
