Second, practice learning. Practical learning is mainly about traffic safety, electricity safety, gas safety and so on. The most important is to improve the ability of college students to deal with common security risks and accidents. For example, how to save oneself, others and others after gas poisoning, teach students how to use electricity properly, and find out the hidden danger of power supply, and correct treatment plan in case of fire.

4.3. Strengthen educational evaluation

Safety education needs education evaluation, otherwise it is difficult to improve the level of safety education dynamically. It is necessary to construct evaluation system, including evaluation index, evaluation standard and scoring standard. Evaluation indicators not only include first-level indicators, that is, whether the teaching objectives are clear, whether the teaching methods are novel and effective, and whether the teaching results achieve expectations, but also need second-level indicators, for example, whether the teaching objectives are clear or not, including clear objectives and unclear objectives. The evaluation standard reflects the importance of safety education and makes clear the significance of cultivating college students' safety awareness. Because it does not highlight the importance of safety education, it does not promote the formation of college students' safety awareness. These two correspond to fractions.

5. Conclusions
