Research on the Influence of Roosevelt's New Deal on American Social Security System

Abstract: The social security system that ensures the most basic living needs of residents is very important for a country. The Roosevelt administration advocated the establishment of a government led social security system, taking different key and forms of unemployment relief, employment expansion, social security legislation and other measures to solve the problems of employment and poverty in American society, and achieve the goal of national intervention in the economy, regulating social production and easing political contradictions, which had a huge and far-reaching impact on the whole American society. On the basis of summarizing the relationship between Roosevelt's new deal and social security system, according to the applicable background and specific content of Roosevelt's new deal, this paper focuses on the impact of social security policy in the "New Deal" on American economy, society and politics, in order to provide useful reference for establishing and perfecting China's social security system.

In the face of the depression caused by the economic crisis, after taking office as the 32nd president of the United States, Roosevelt, on the basis of conforming to the will of the people, combined with his previous ruling experience as governor of New York, decisively implemented a series of policies and measures against the crisis [2].

3. Impact of Social Security System

3.1. Impact on the Economy

(1) Increase the disposable income of citizens and promote the sound development of the American economy.

Roosevelt's new deal provided employment opportunities for a large number of unemployed people through government investment and construction of public works, made up for the lack of human demand in the current society by means of government spending, promoted the demand for production, increased people's income and increased people's purchasing power while building national public utilities, In this way, new social needs are formed again, so as to achieve the purpose of recycling the government economy. (2) Promote the smooth reproduction of labor force and form the regulator of American economic and social stability.

3.2. Impact on Society

(1) Ease social contradictions and promote the sound development of society.

After the adoption of Roosevelt's new deal, it has largely alleviated the negative impact caused by the American economic crisis. The social security act has formed a guarantee for the uncertain factors in people's life to a certain extent, that is, it has guaranteed the supply of their basic living standards, so that they are no longer forced into a desperate situation due to unexpected risks or economic deterioration, It alleviates social contradictions and promotes the benign development of society.

The role of Roosevelt's new deal in regulating the economy is essentially the process of the distribution and redistribution of national income, rebuilding economic balance, realizing social equity and maintaining social stability.

Although the measures of social security system in Roosevelt's new deal were carried out under the great environment of the great economic crisis of the United States, with the outstanding achievements of Rural Revitalization and the continuous development of socialist market economy, we can draw lessons from its essence and provide reference for the improvement and development of China's social security system in the contemporary society.

1) Improve the urban and rural social security system and stimulate the consumption potential of urban and rural residents.

According to the different development characteristics of cities and villages, we should implement a targeted social security system, strengthen the design of social security system, and promote the equalization of social security content. Clarify the audience scope and security conditions of urban and rural social security system, optimize rural basic public services, improve the deficiencies and deficiencies of urban social security system, and gradually coordinate and promote the establishment of inclusive urban and rural social security system. The population of registered residence in China still occupies the majority in our country. With the constant implementation of the strategy of Rural Revitalization and the continuous development of new rural economy, our country is experiencing hitherto unknown economic development and infrastructure improvement. 3) Pay attention to spiritual care and improve the awareness of "Self-protection" of social members. China's traditional social security system pays more attention to the scope of social security, and

4) Carry out collaborative guarantee of third-party organizations to improve social security.

Through the introduction of the third sector, social groups and community organizations are added, and government organizations, public institutions, economic groups and other multi subjects are encouraged to participate in and jointly carry out social security work, so as to further improve China's social security security security. Strengthen the front-line role of social groups and community organizations, improve their welfare service efficiency, and make them the main force of social services. While the government ensures residents' stable employment and stable life, the participation of social organizations makes the social security system more humane and humanized.

To sum up, the ideas and means proposed in Roosevelt's new deal, such as reviving industry, adjusting agriculture, establishing social security system and "work for relief", not only helped the United States out of the crisis, but also made it the first country in the world to form a systematic social security system. If we can observe the impact of Roosevelt's new deal on the social security system from the objective requirements of historical development and the overall trend of social development, set the plate, clarify the way and open the right prescription, it will make our country deepen and consolidate on the road of exploring the social security system.
